market value of \$1,635,030. The items in addition to food was  
needed clothing, shoes, coats, baby food, diapers, incontinence  
supplies and fans.

Services to administer the Crisis Intervention Program, Low Income

processed by ECCCCM case workers. The applications are then forwarded to  
the County for payment. Through these programs, ECCCCM assisted an  
additional 5,528 individuals with financial assistance of \$932,623.
